

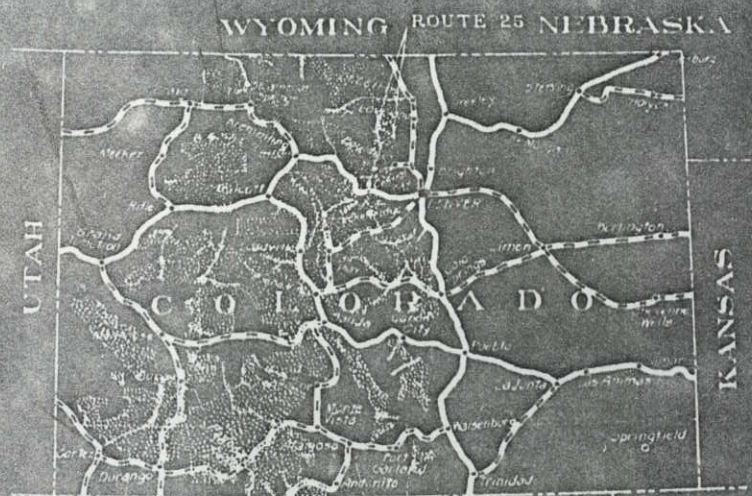

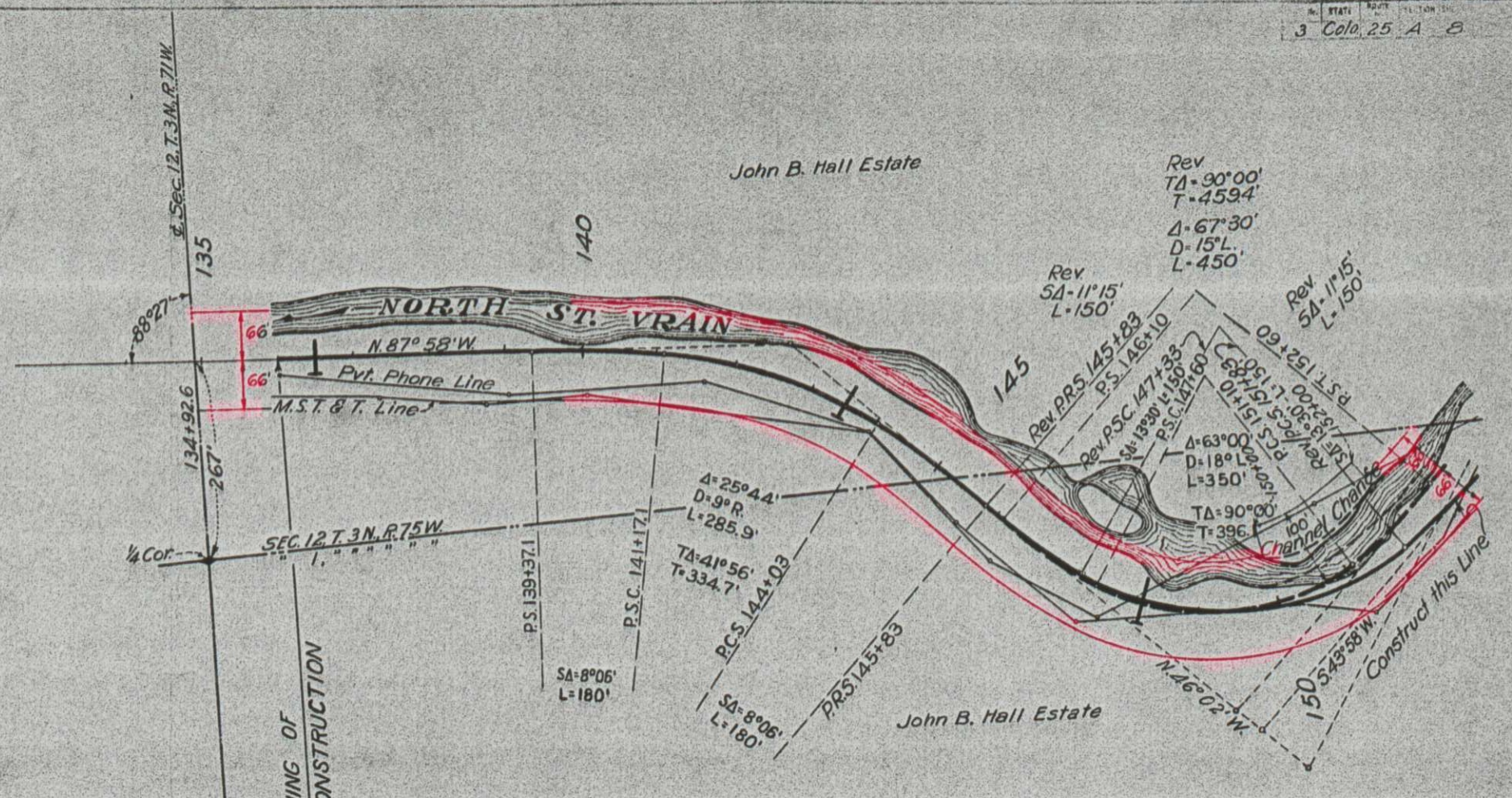

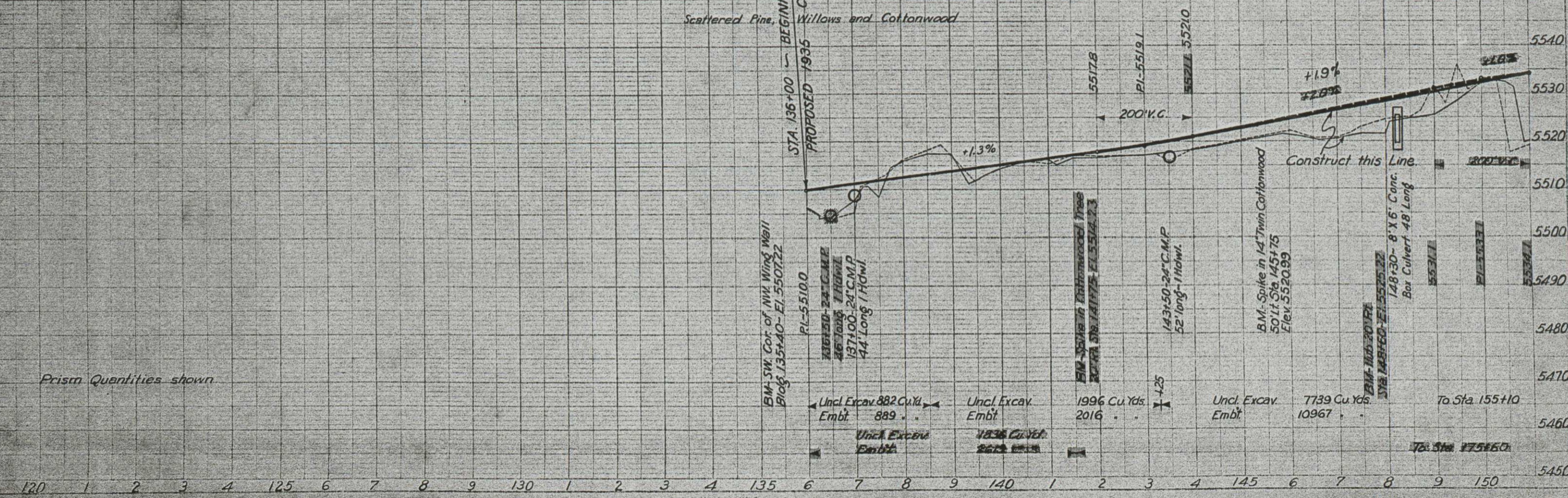

Scattered Pine, Willows and Cottonwood



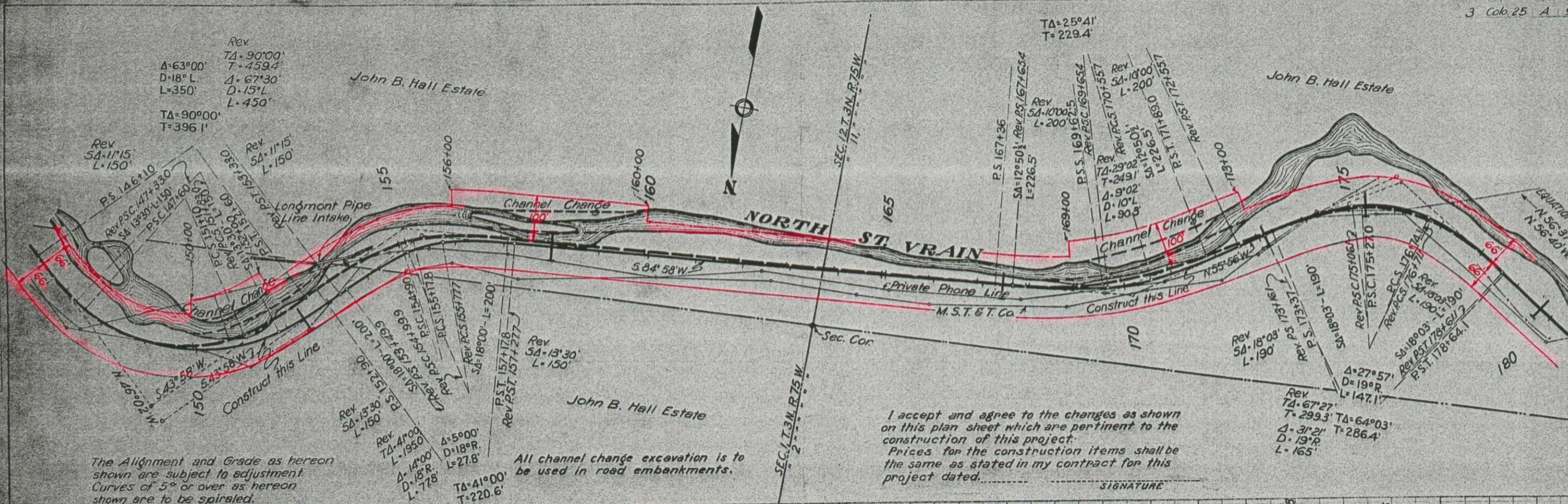

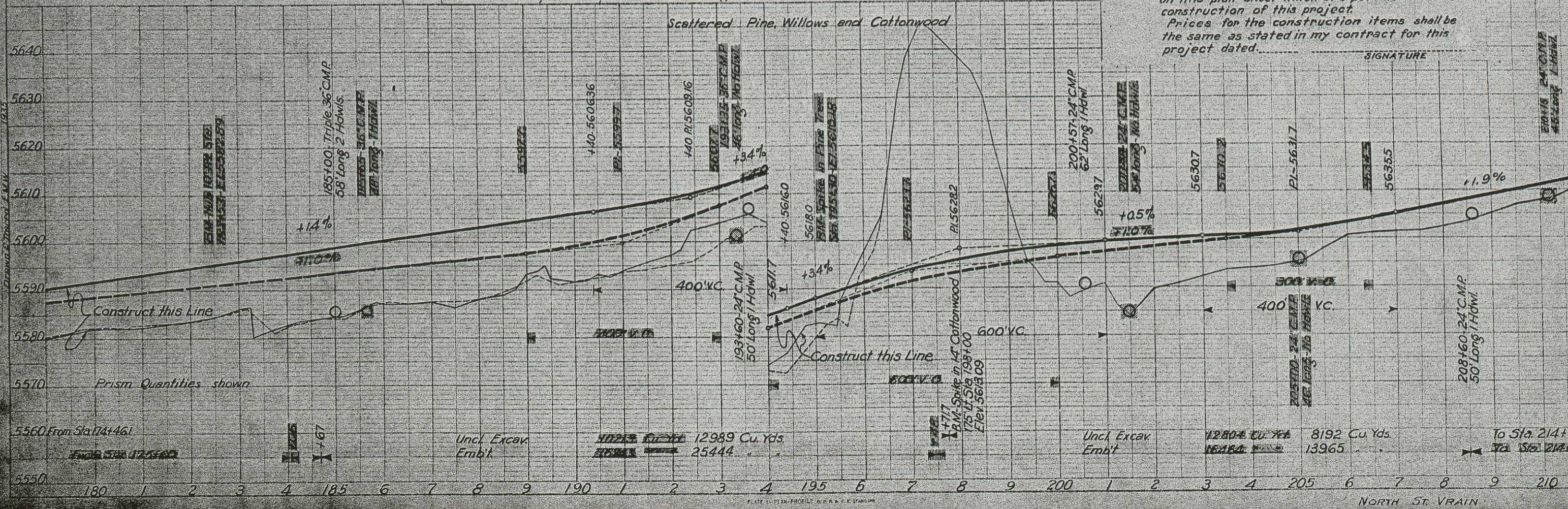
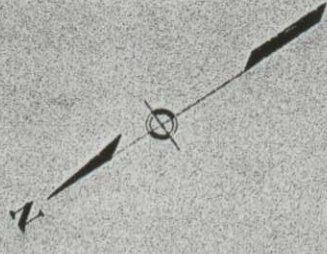
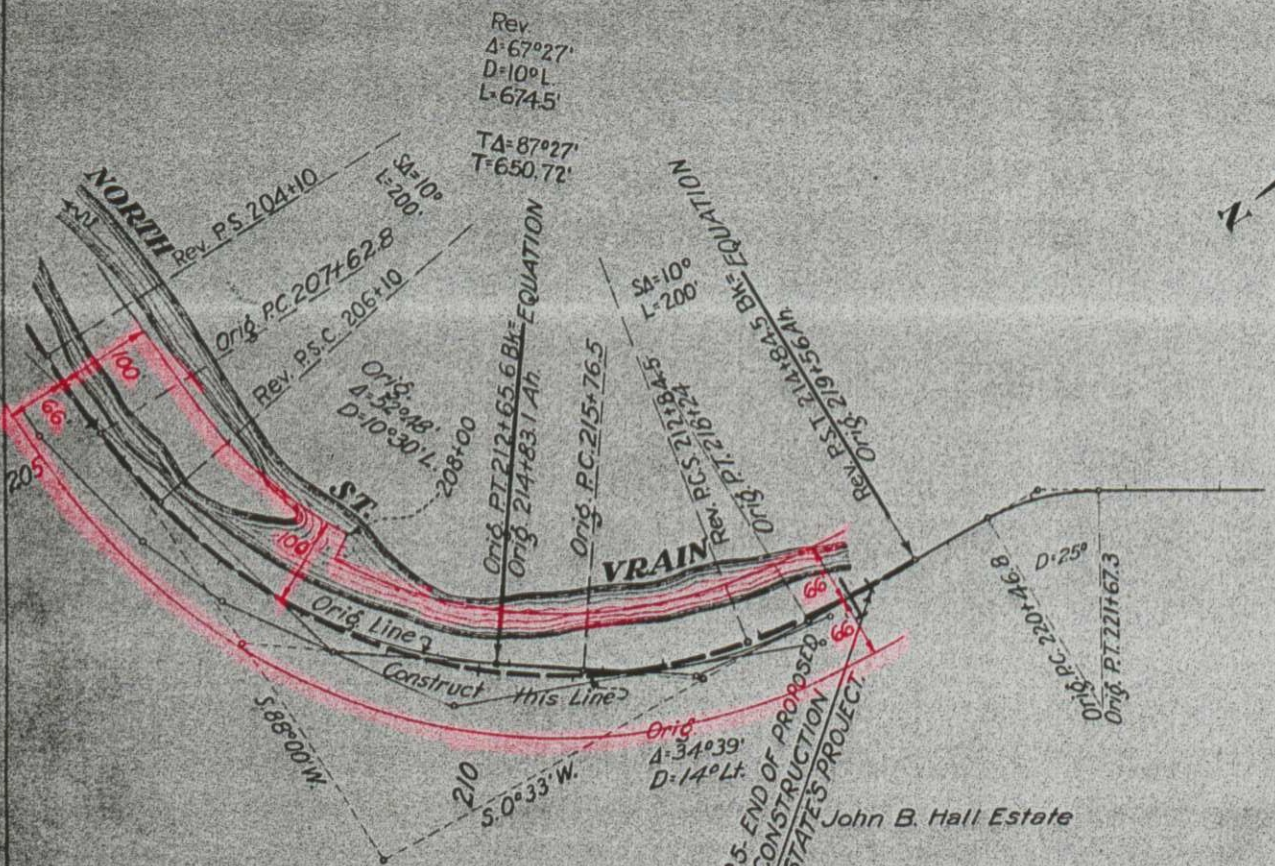


PLATE 1 - PLAN, PROFILE AND PRISM QUANTITIES

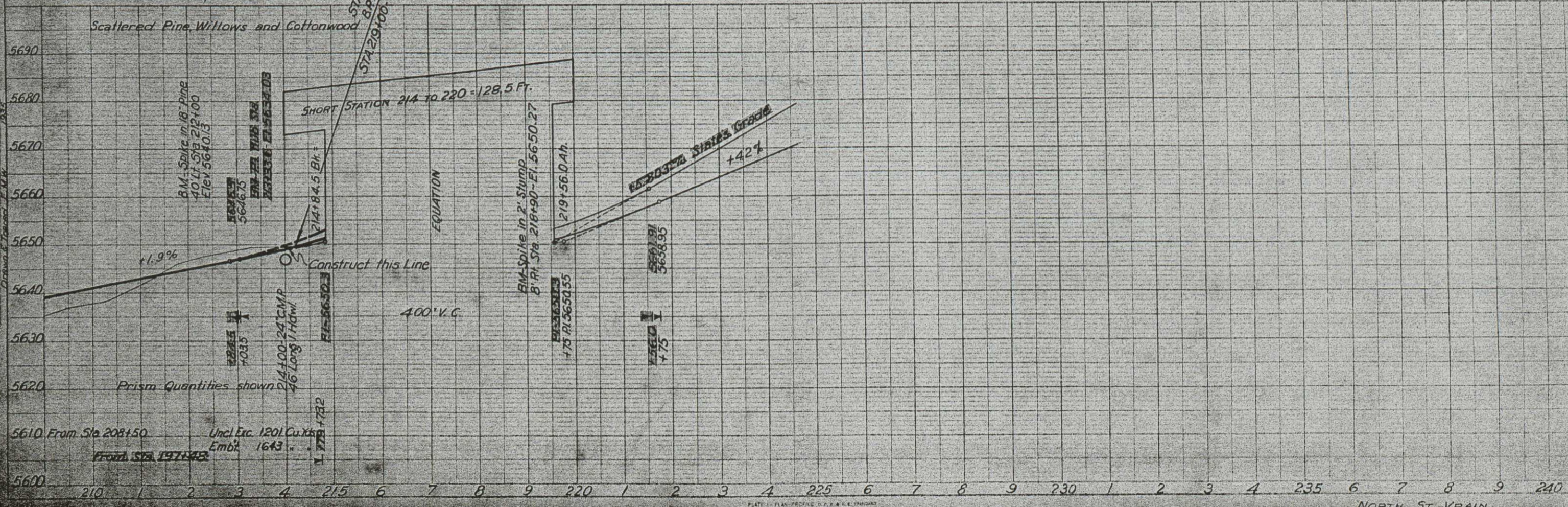


PLATE 1 - PLAN - PROFILE C. P. & R. E. SPENGLER
