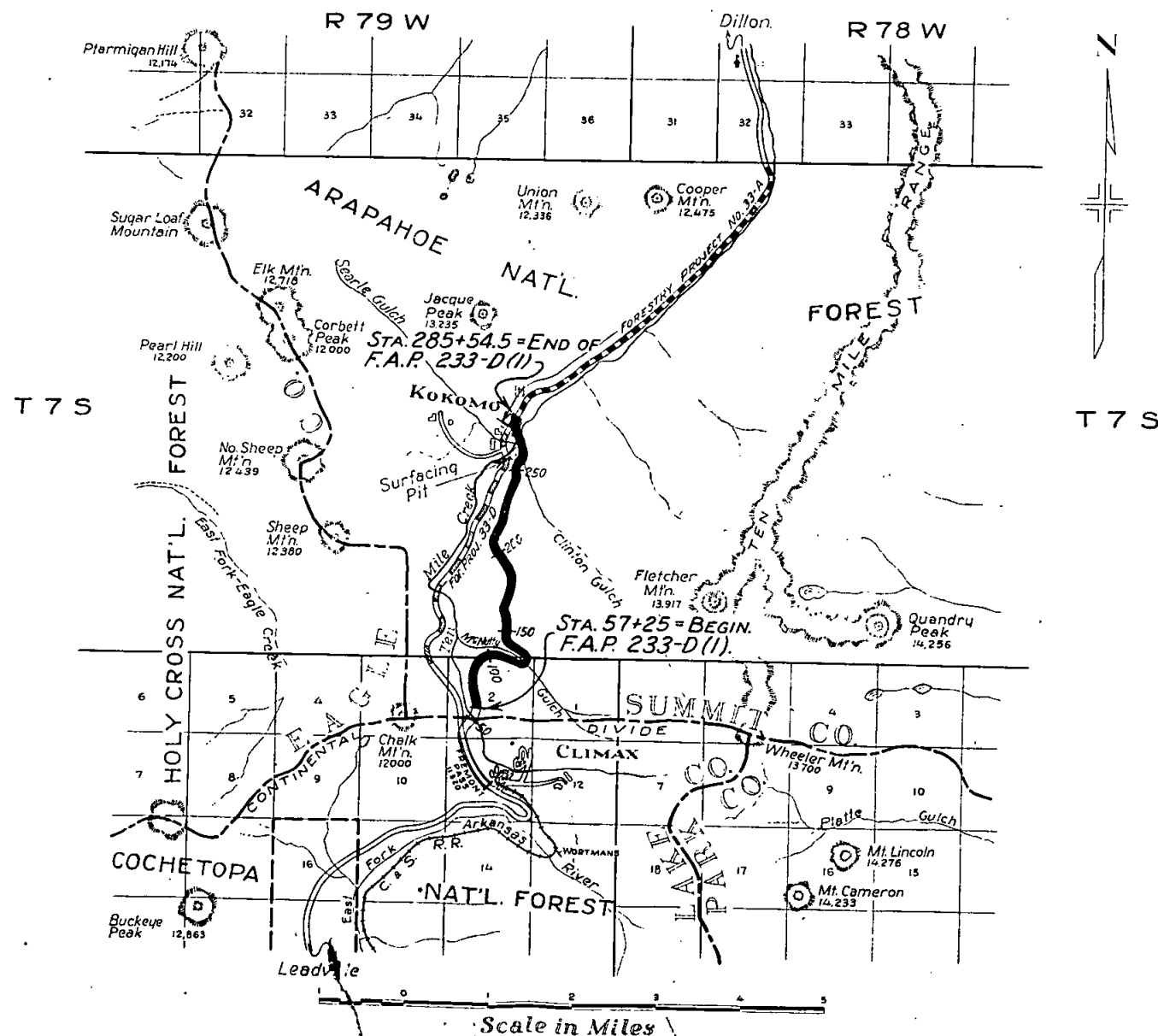

Rev. 4-16-40-J.W.S. Intersecting Ditches



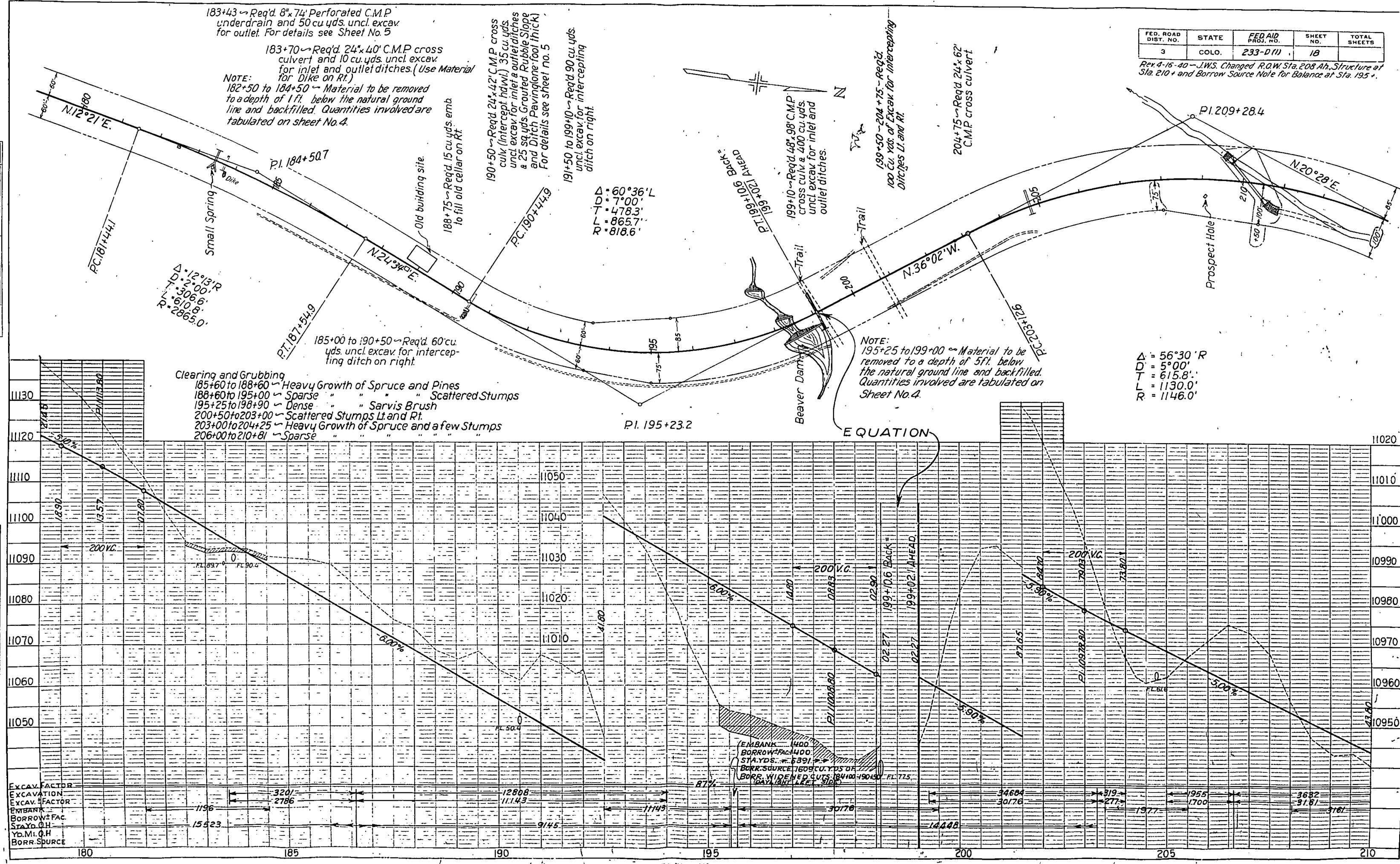
