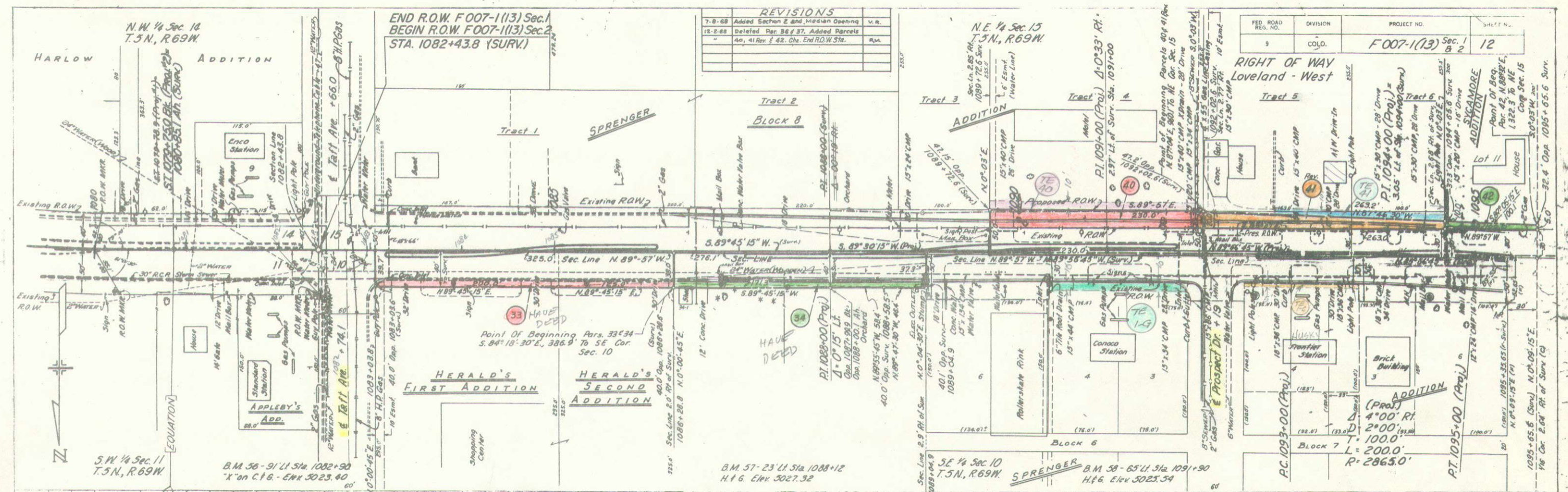

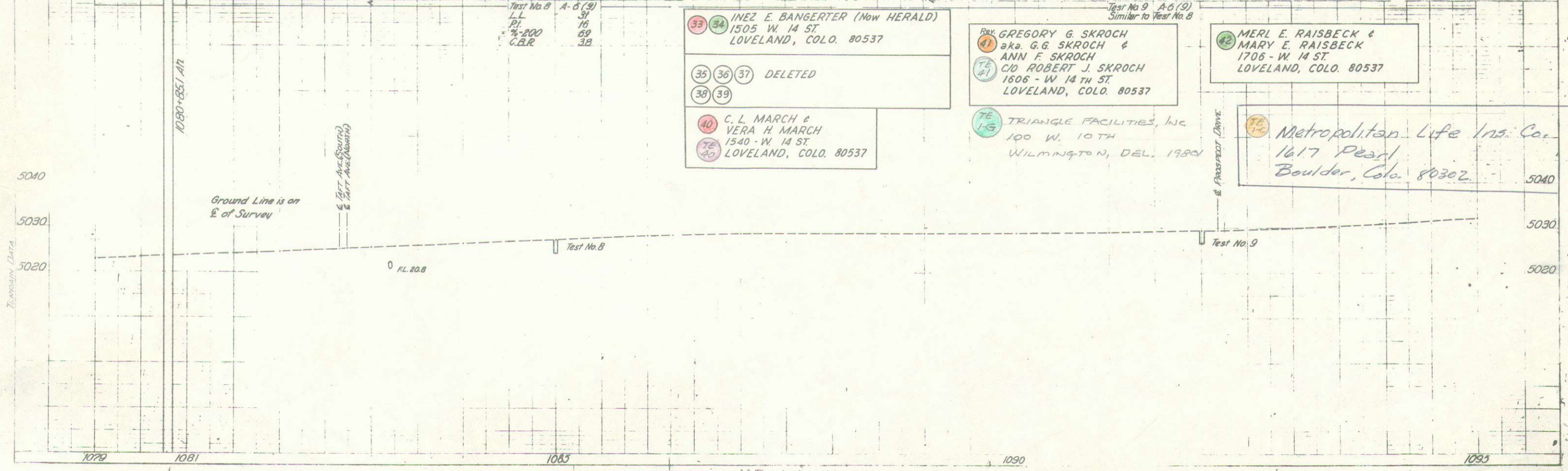

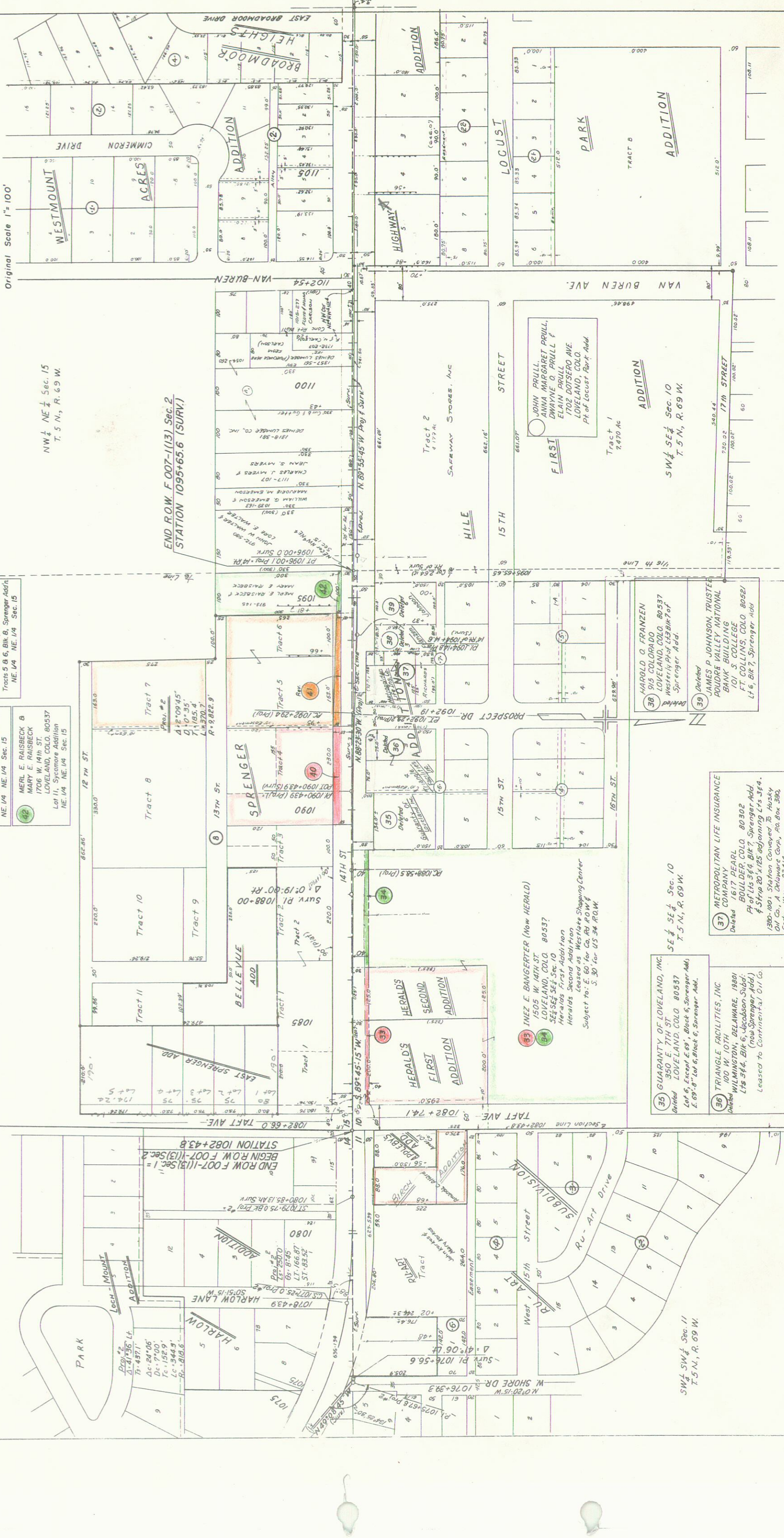
Property Ownership Map
