Transmittal of Right-of-Way Authorization Plans

In accordance with the CDOT Right-of-Way Manual, Chapter 11, Section 2.1, and Title 23, Chapter 3, Section 317 (a), Code of Federal Regulations (CFR), the following items for the above-referenced project are attached:

• Three sets of 11" x 17" Right-of-Way Plans with Three (3) Parcel Legal Descriptions included as part of the General Notes and Tabulation of R.O.W. Markers Page.

CDOT owns the existing right-of-way in fee simple. The U.S.F.S. will be developing the new acceleration and deceleration lanes on its land. CDOT's expanded highway will occupy the land via a Highway Easement Deed granted by the Forest Service.

Approval of the attached Right-of-Way Plans is required as an early step toward completion of the easement deed. The three areas covered by the legal descriptions are cross-hatched on the plans.

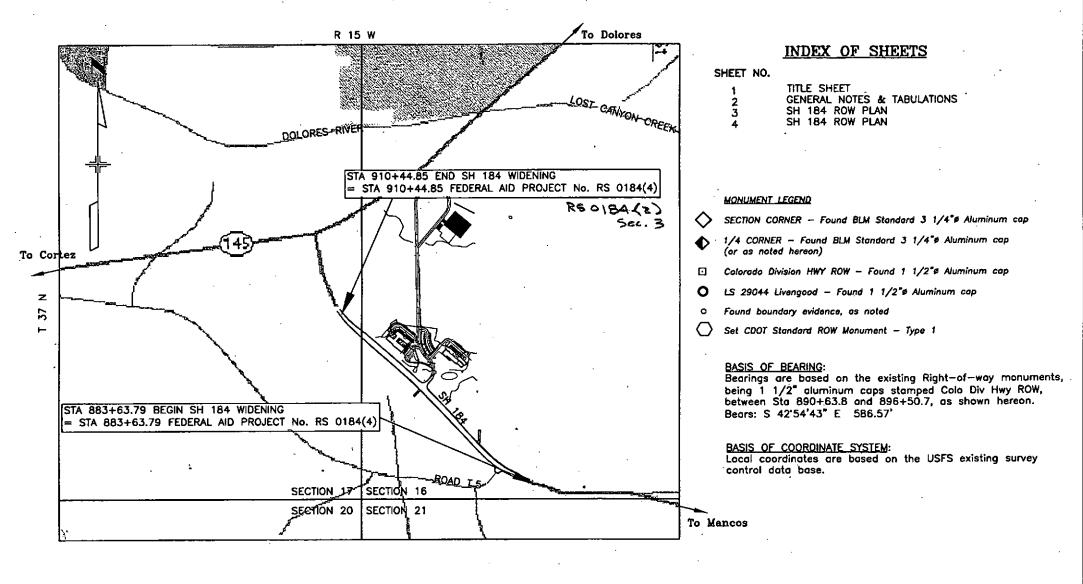

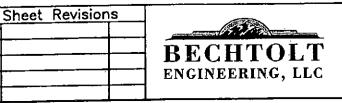
