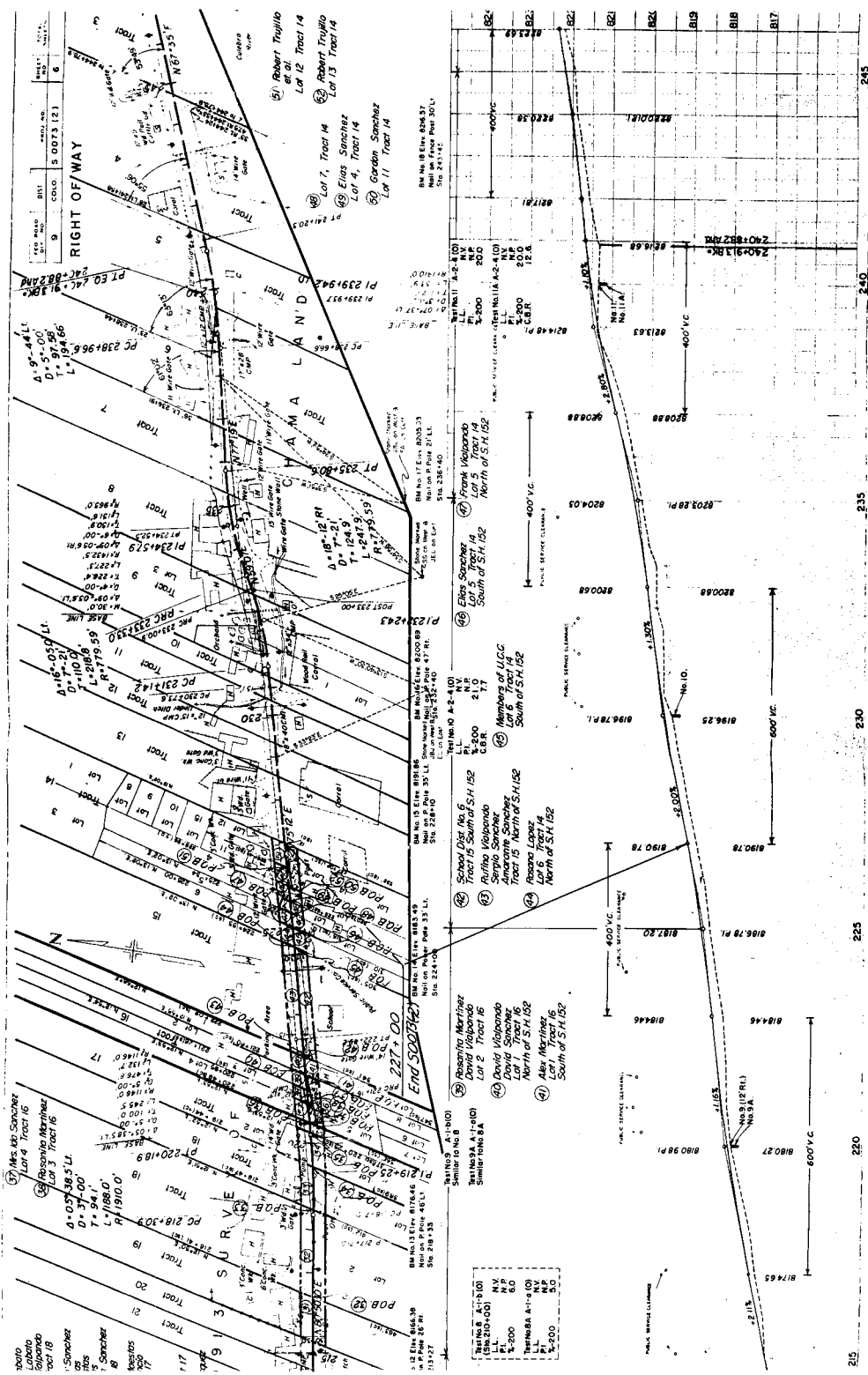

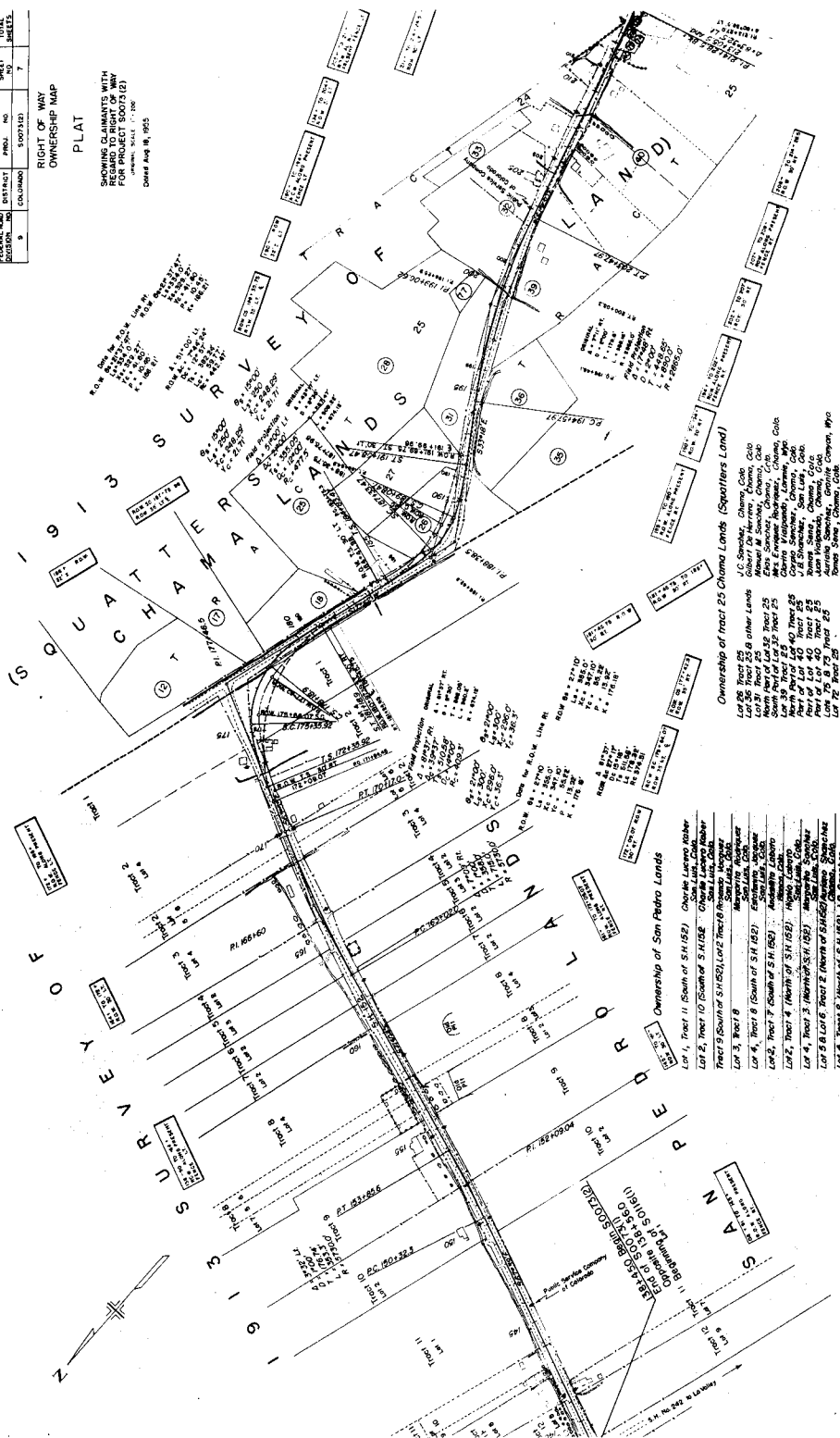

FOR PROJECT S0073(2)

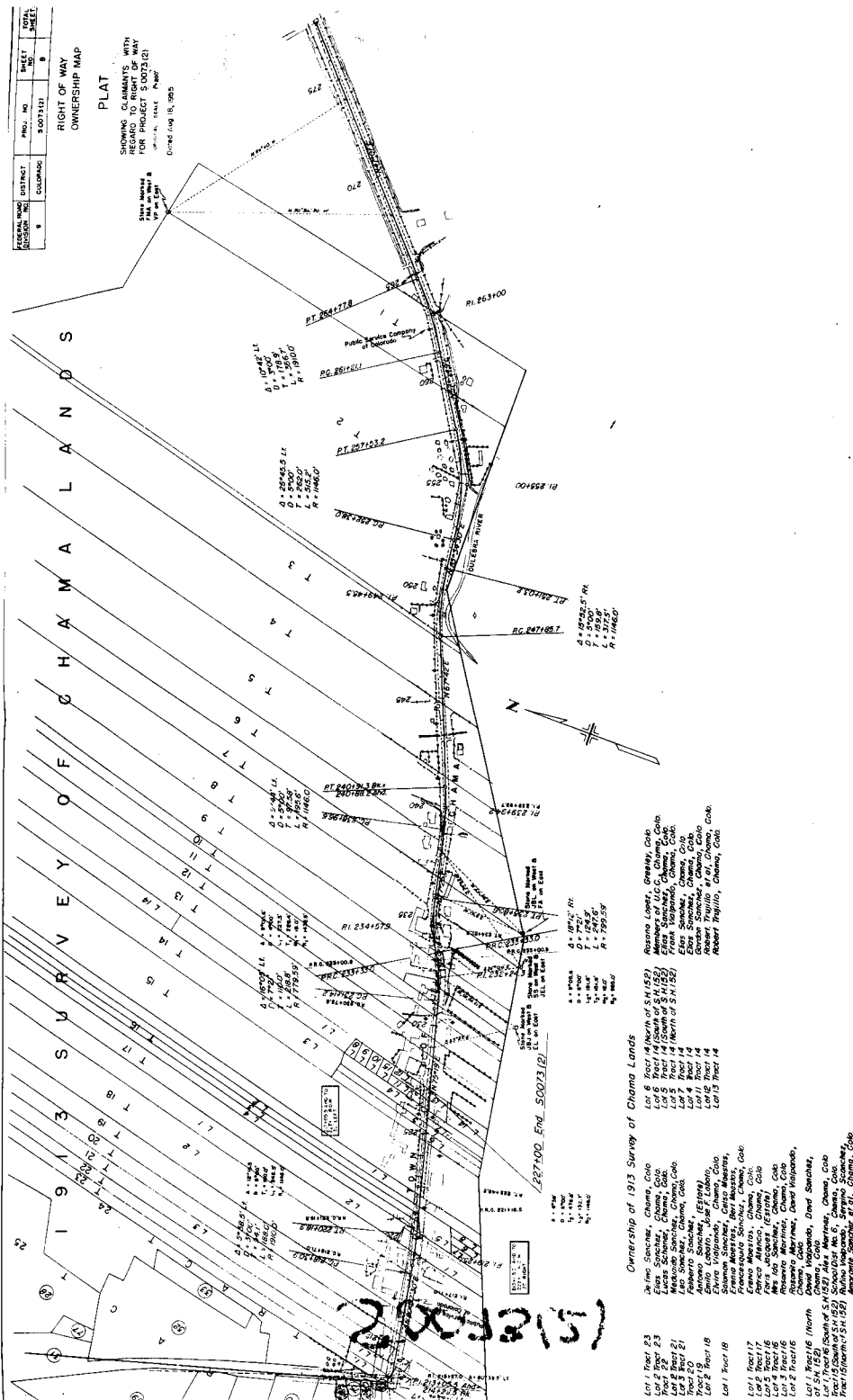
