 - 4) Separate zoning maps for each PLD Reserve are recorded with the county clerk.

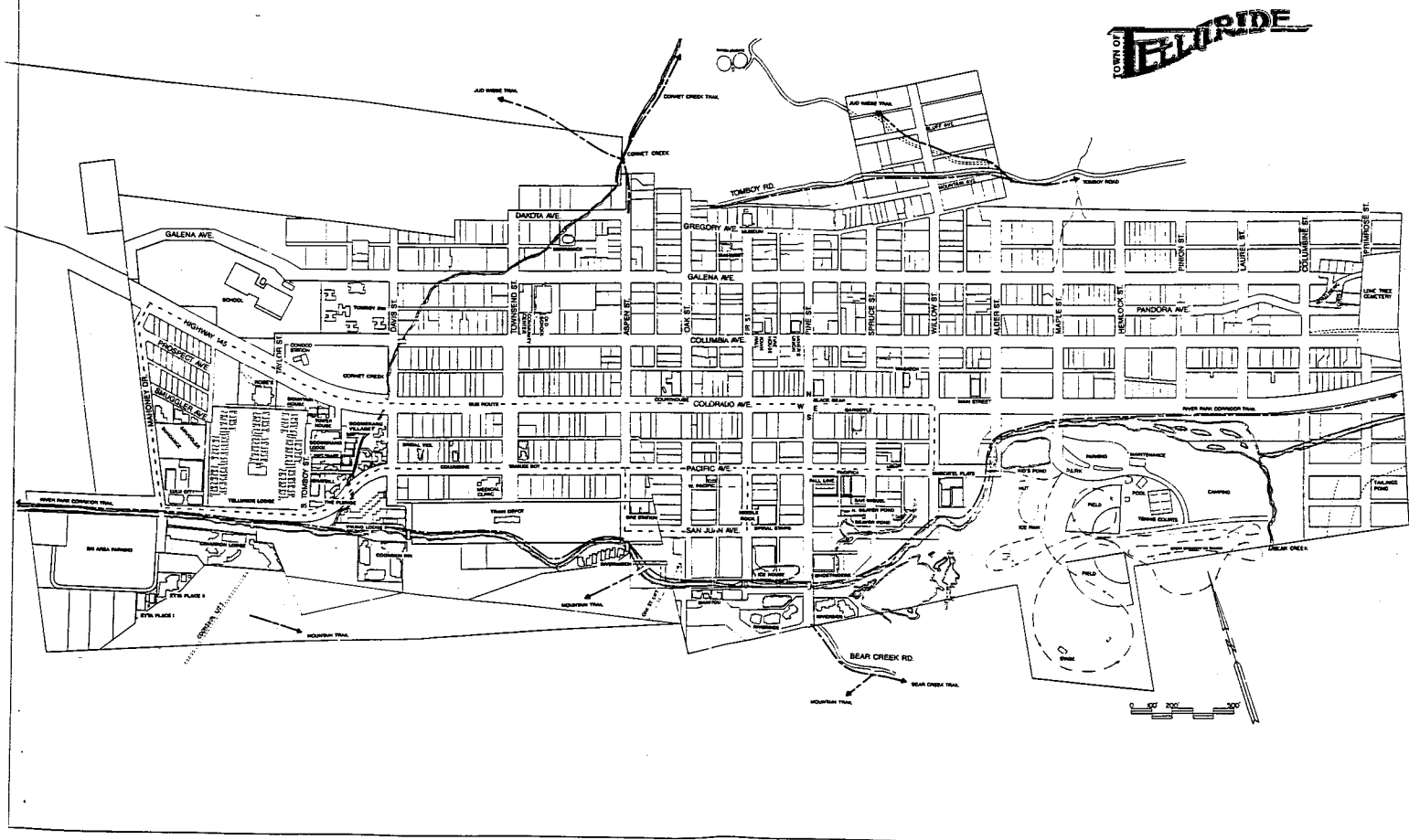

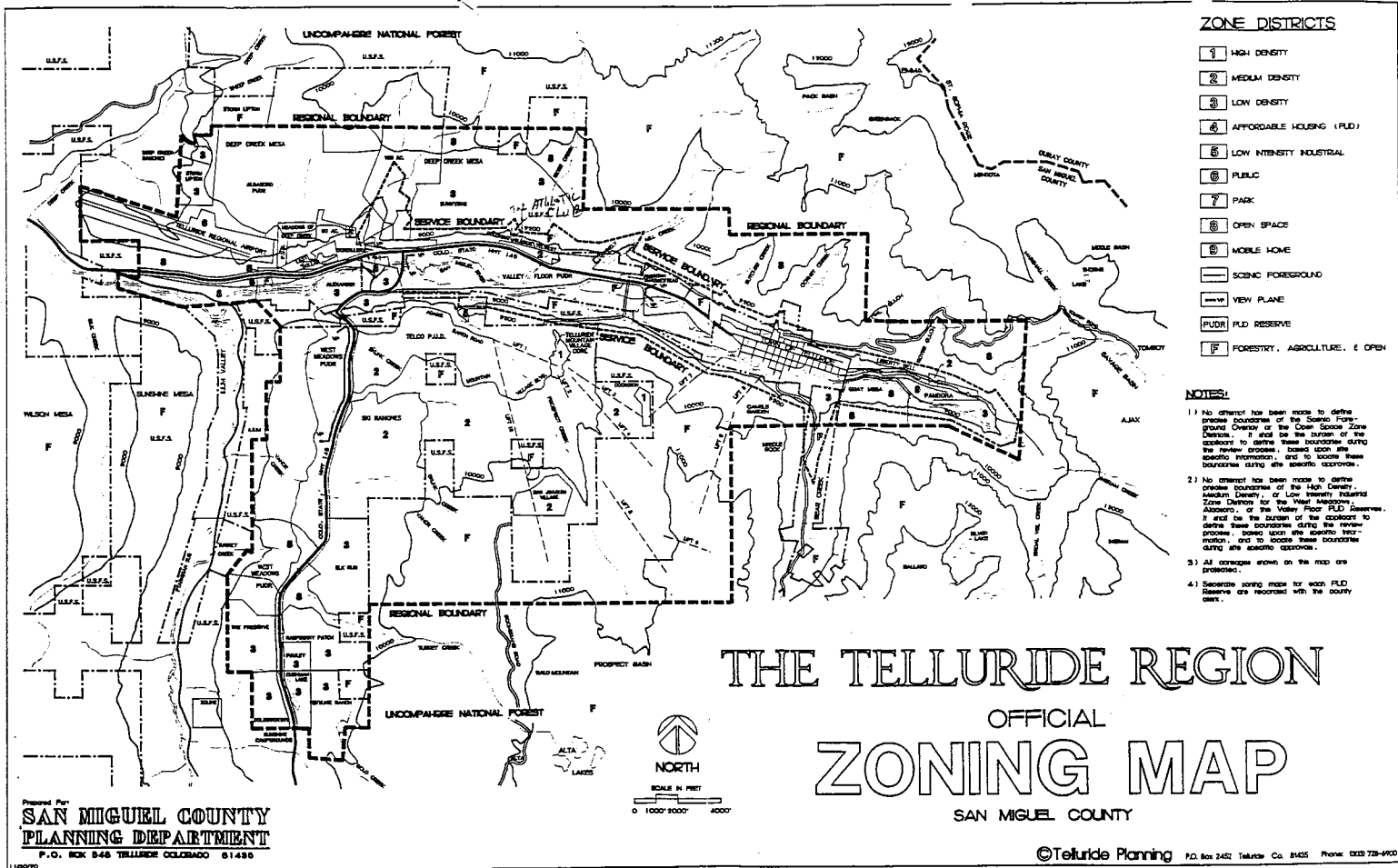
OFFICIAL ZONING MAP
